Minutes for GENERAL MEETING held in clubhouse on April 24, 2014

SPEAKER: Tim Sheahan from GSMOL (Past President of GSMOL and currently VP for Zone D)
Golden State Manufactured-home Owners League, Inc. (GSMOL) is a nonprofit homeowner advocacy organization, dedicated to protecting the rights and quality of life of manufactured home owners. GSMOL educates home owners on their rights, solves problems for manufactured home communities throughout California, and supports legislative efforts, including improving the Mobilehome Residency Law (MRL).
NOTE: This covers manufactured/modular/mobile/trailer/coach homes throughout California.
Tim gave examples of how GSMOL has protected members from unfair rent increases and unfair evictions, etc. Current legislation is AB2026 (Stone) against mgmt. interference in selling of homes in park. Tim urged everyone present to mail the postcard provided to our local assemblyman and mail to State Capital.

We need 15 GSMOL members in the park to reactivate our chapter. Everyone urged to join. Membership is \$25.00 for one year. The Californian newsletter keeps members informed of legislation and articles relevant to our homes.

Appeal for new GSMOL members: Mel and Jack urged everyone present to join.

First meeting of GSMOL members: Thursday, May 15, 2014-to elect officers and get started.

Tickets for drawing: Fran distributed tickets. Prize is one year membership to GSMOL

Minutes from last general meeting (Oct 2013) - Fran referred members to October newsletter where minutes were published. Bill reported an error. His website should be changed to www.chollascreek.org. Motion by Larry to accept minutes with the one correction, Seconded by Paula. Approved.

Treasurer's report: Paula distributed copies of her report. Balance Oct 2103= \$1422.47 and now \$1564.21. Increase of 141.74. Breakfasts have helped increase the funds. Motion by Lyn to accept report, seconded by Renee. Approved.

Dues update: Paula reported that with members joining tonight we now have 34 spaces represented.

Questions on 3x5 cards: Jack requested everyone write any suggestions/ complaints/ ideas on the cards distributed by Alice. The board will address them.

Management report: Bill and Theresa did not attend. No report.

Breakfasts report: Bob reported these are going very well. Good food, lots of fun and laughter. (May one is 10th instead of first Saturday). Everyone encouraged to attend.

Breakfasts reminder phone list: Alice said to let her know if you need a phone call reminder about Breakfast day and/or meeting nights. Also if you have fruit on your trees that you want to donate to residents in the park.

Age and Independence help for seniors/ publications: Alice reported that she has these available to residents. Call her if you want to receive them.

Sharps program report: Jack reported that he is currently helping 14 residents with needles disposal. He provides the jars, labels and delivery/pick up. This program has been in place for 2 years now. Mel helps. The list is confidential. Call Jack if any resident needs help with diabetes supplies disposal.

Medical Equipment available: Jack reported we have commodes, walkers, etc. available to any resident in need. (These have been donated by other residents). Call Jack.

Chollas Creek update: Bill reported next workday is this Saturday. Those interested meet at the end of the frontage street to work on removal of invasive plants and upkeep on the trail. Bill urged residents to NOT leave food outside for any reason-it attracts rats/ coyotes. Also, rattlesnakes have been seen in the park and creek area. Bill encouraged everyone with dogs to keep them on a 6 foot leash to protect from snakes.

Table games night report: Fran reported that the group meeting on second Monday evening of the month in the clubhouse kitchen has been having fun with various table games. Encouraged residents to come and join in. Next one is May 12th.

Introduction of LRA website: Mel www.lrasd.us is up and running. Check out the links!

Jack has printed up cards with the web site information- these were distributed and will be on the bulletin board.

LRA bulletin board: LL management has designated a poster board in kitchen for LRA only. We can post information for residents. Be sure to thank Theresa for this.

ELECTION OF OFFICERS: Bob turned over proceedings to Mel.

Mel presented the slate and asked if there were any nominations from the floor.

As there were no nominations from the floor, the officers were elected by acclamation!

INPUT FROM RESIDENTS:

1. Lyn inquired about the way we have only two general meetings a year so dues have to be paid in Oct for the following year. This is confusing. Mel said he would look into the bylaws wording and see if anything could be changed.
2. Mel urged residents to send him anything they would like to see in the newsletters. Ramona suggested the advice about not leaving food out should be included.
3. Bill suggested we look into asking management about setting up a dog run within the park. This way dogs could be allowed off their leashes. The LRA board would have to work out volunteers to clean up etc.

- Joe suggested we look into solar energy for the residents. He would like to see a contract as a group, not through SDG&E, to install solar panels on the homes. Bob asked Joe to bring his idea and research details to the next Board meeting.

Alice collected 3x5 cards that had been filled in- for Board to work on at their next meeting.

Bob encouraged everyone to come to the monthly Board meetings. They are held on 2nd Thursday of each month and the next one is on May 8th.

GSMOL helped spread the word to county residents to encourage their supervisors to vote in favor of the conversion.

Let's pull together! Let's be neighborly

Good neighbors do kind things for/ to each other. Here are some suggestions that were made at the LRA General meeting:

Keep your dog on a leash in the park and keep the dog on the road only- not straying on to resident yards/grass areas. Not only is this a courtesy but some residents spray weed killer in their front yards which is harmful for dogs.

Keep your dog from barking at passersby and vehicles. It causes stress and upset for your neighbors.

Only drive at 15mph in the park. Going faster is against the park rules and is upsetting to neighbors. Many residents walk dogs or take walks in the park.

When walking in the park, stick to the side of the road when a car is approaching.

Don't leave food outside for your pet. This attracts rats and other rodents and coyotes will be drawn into the park.

Beware of rattlesnakes- yes, even in the park. They have been seen in the past. The upcoming hot, dry summer will bring them out.

Talk to Alice/Fran if your street light is blocked by trees and needs pruning so the street is better lit.

If you know of a resident that is shut-in, please see if you, or the LRA board, can help them in any way. Let Alice know if they are willing to be helped by us.
