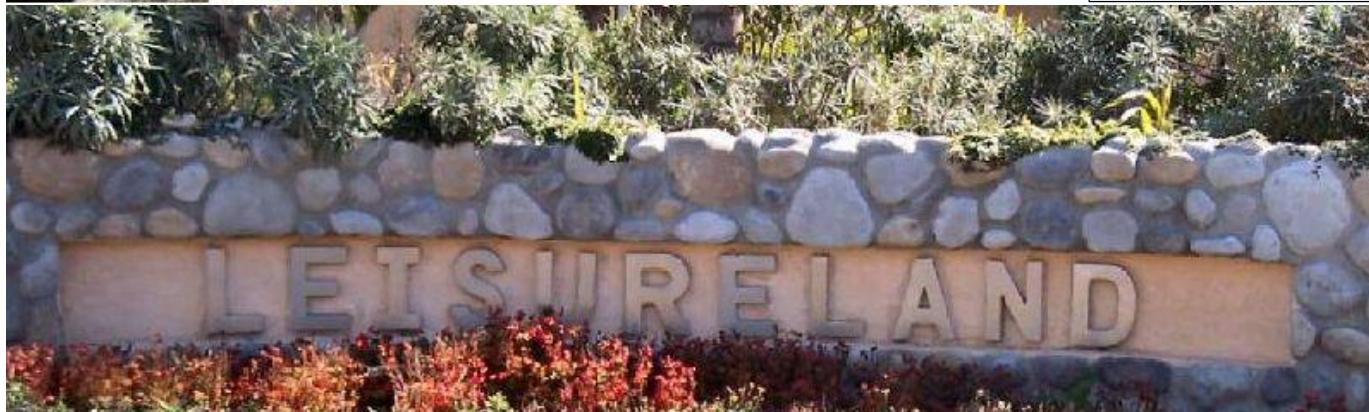

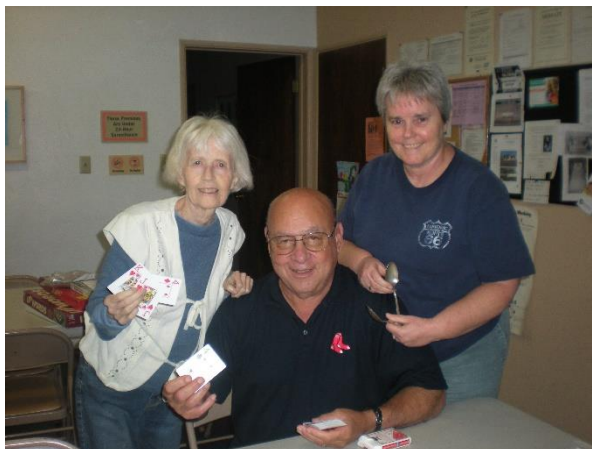

This new tax is expected to **increase the cost of gas between 16 and 76 cents per gallon***, according to the California Air Resource Board (CARB).
